GUIDANCE ON TRANSACTIONS WITH RELATED PARTIES

The definitions are:-

- Related Party members, officers and advisors and close family or members of the same household of those individuals.
- Related party transaction the transfer of assets or liabilities or the
 performance of services by, to or for a related party, irrespective of whether a
 charge is made.

The disclosure requirement takes the form of a note to the accounts, which shows an aggregated position in respect of transactions with all related parties. Details of individual payments etc. do not, therefore, have to be disclosed. It is also not necessary to disclose information that is disclosed elsewhere, for example, it is not necessary to include normal remuneration payments, e.g. salaries/ members' allowances and reimbursement of expenses. Also excluded are any transactions that arise which are generally applicable to all members of the community e.g. Council Tax payments.

The guidance on what should or should not be included in this area is a matter of judgment but also has to take account of whether any transaction is material from the perspective of the related party. Examples of the type of area covered by this note would be:-

- **a.** where Warwickshire's Office of the Police and Crime Commissioner has sold an asset to a related party;
- **b.** where a related party has received any benefits, over and above salary payment related to their employment, from Warwickshire's Office of the Police and Crime Commissioner, for example, payment for goods and services;
- **c.** where a related party has an interest on a voluntary body, charity or similar, perhaps as a member of the management committee who receive a grant from or have dealings with Warwickshire's Office of the Police and Crime Commissioner;
- **d.** any partnerships or directorships in businesses held by a related party (this disclosure helps to provide transparency and accountability in all that we do and serves to protect the integrity of individuals and the force);
- **e.** any land held by a related party (other than their principal residence) in which they have a beneficial interest:
