



### LAUNCH EVENT FOR THE 2019/20 PCC ROAD SAFETY GRANTS

<b>1. Summary of the application</b>			
To provide a small event on 12 <sup>th</sup> April 2019 to launch the 2019-20 PCC Road Safety Grant in Warwickshire, and to enable partners to network.			
<b>2. Background information:</b>			
The first PCC Road Safety Grant launched for applications in May 2019. Prior to this, in April 2019, there was a networking launch event for the grant as it was the first of its kind, and it was important to disseminate information about and promote awareness of the availability of funding. It was also a very positive opportunity for the OPCC policy leads to meet with prospective partners and applicants to encourage partnership working going forward.			
The cost of this event is restricted to catering only as room hire was not required due to availability of a police estate venue.
