3/10/11/2020	COVID Update – briefing by ACC Tedds <ul style="list-style-type: none"> • There is a rise in the current situation nationally. • Warwickshire is currently continuing to see an increase in the number of infections, this rise is slightly slower than we saw in the first wave of the virus • Hospitalisation within Warwickshire has gone up from 91 to 110, again still relatively low and manageable with hospitals still continuing routine hospital work. • Students will be returning home between 3-9 December. All will be tested before they go home. Latest figures show 22 positive cases at Warwickshire University. • Absence rate in Warwickshire schools in now at 10%

	<ul style="list-style-type: none">• Force are seeing a steady rate of absence levels presently which is being monitored.• Continued Covid secure compliance checks are being carried out at Warwickshire Police.• Warwickshire Police are awaiting the government announcements for the next measures and continuing to plan for what the next phase of restrictions may look like ensuring the right resources are in place. <p>PCC asked if the Resilience Forums are working well in adapting to the changing scenarios. ACC Tedds confirmed they are working alongside other committees effectively with district boroughs and partners sharing information and support working successfully.</p> <p>PCC asked if there was any early evidence in crime reduction. ACC Tedds confirmed demand and incidents remain the same with no reduction as in the first lockdown. There is a high demand in Covid19 breaches.</p> <p>PCC thanked ACC Tedds and the Team for the work continually carried out in keeping Warwickshire safe.</p>
