1. Summary of the application

To consider the setting of the precept for the financial year 1st April 2021 to 31st March 2022.

The Commissioner is required to propose a precept to the Police and Crime Panel by no later than the 1st February 2021

The Commissioner is required to act in conformity with the Police & Crime Panels (Precept and Chief Constable Appointments) Regulations 2012.

When setting a budget requirement, the Commissioner must have regard to representations received and any reports of the Police and Crime Panel.

The final precept must be determined by 1 March 2021.

2. Background information:

To assist the Commissioner to determine a proposed precept level, the Commissioner's Chief Financial Officer has prepared the accompanying Budget report, which provides details on the budget, the benefits of that budget, savings required, the MTFP, reserves and the capital programme.

In setting the proposed precept the Commissioner has had regard to public responses and those of Council Tax payer representatives. These have been summarised in the accompanying report.
