2/13/04/2021	<p>Bank Holiday Policing</p> <p>It was noted that there had been no significantly increased policing demand in Warwickshire over the recent Bank Holiday weekend.</p>	
3/13/04/2021	<p>Covid Update</p> <ul style="list-style-type: none"> • Infection rates were slightly reduced (from a low base) with the exception of Stratford upon Avon. • Absence levels within the Force remained low • The number of police officers and staff who had received vaccinations was steadily increasing (337 officers and 262 staff) – there had been a steady flow from surplus

	<p>vaccines and those individuals vaccinated followed the age profile with frontline staff prioritised.</p> <ul style="list-style-type: none">• Significant lockdown breaches continued to be enforced. As some of the regulations and restrictions were lifted Warwickshire Police would continue to work in partnership with Warwickshire County Council to ensure the public understood what constituted “outdoors”. A rise in policing demand was expected to coincide with the lifting of restrictions and the finer weather.• The Force remained vigilant and prepared for any further waves.• Regular COVID19 testing of personnel was progressing targeted around the Control Room and training areas. As further supplies were received they would be issued to staff to maintain internal COVID secure standards.
