1/15/06/2021	<p>The minutes of the previous meeting held on 8th June 2021 were agreed as a true and accurate record.</p> <p>There were no matters arising.</p>	
2/15/06/2021	<p>Local : COVID Briefing</p> <p>DT gave a comprehensive briefing to the Commissioner. Of particular note:-</p> <ul style="list-style-type: none"> Force acknowledged the Government's announcement of a 4-week pause at Step 3 with the majority of restrictions remaining in place. Up-to-date information on what the public can and cannot do could be found at www.gov.uk . Warwickshire continued to see a relatively high level of compliance. Absence levels continued to remain static at 5% for police officers and just under 5% for police staff. Infection rates continued to rise across Warwickshire. Highest rise was in Nuneaton and Bedworth at 76.2% with

	<p>the lowest in Warwick at 23%.</p> <ul style="list-style-type: none">• Hospitalisation figures currently manageable.• Enforcement and COVID related police calls had reduced significantly.• Increased reportage on non-compliance of quarantining after foreign travel.• A number of incidents reported with regard anti-vaxxers.	
3/15/06/2021	<p>Local : New Chief Constable for Warwickshire</p> <p>PR reported that the Police and Crime Panel had approved the appointment of Debbie Tedds' as the new Chief Constable for Warwickshire at their meeting on 11th June 2021.</p> <p>The meeting, which was livestreamed so the public could also watch, allowed members of the panel to question T/DCC Tedds and also received a report from the Commissioner outlining the interview and selection process in full.</p> <p>The Panel, made up of elected and independent members from across Warwickshire, had the power to veto the appointment but voted their approval of the Commissioner's nomination.</p>	
4/15/06/2021	<p>Local : Operational Update</p> <p>DT reported on the high level of policing demand over the last weekend.</p>
