Staff 105 staff posts are accounted for in shared / hosted services. There will be a change in the staff establishment in Sept 2021 with numbers lowering as shared / hosted services end. 2 members of staff on Financial Services will move across from West Mercia to Warwickshire. Specials / Volunteers Aspired target of approximately 130 Specials by end of 2021. It was noted the OPCC are in the process of recruiting volunteers under ISVAs and Appropriate Adults programs.
